



## The Leadership Challenge® Workshop Facilitator Development Process

### Background

In 2004, Pfeiffer, an Imprint of John Wiley & Son, entered into an agreement with James M. Kouzes and Barry Z. Posner, thus becoming the exclusive publisher of *The Leadership Challenge® Workshop* materials. Pfeiffer is also the publisher of the *Leadership Practices Inventory (LPI)*, *LPI Online*, and other workbooks and tools developed by Jim and Barry.

Our strategic aim is to make *The Leadership Challenge® Workshop* materials widely available to the training and leadership development market. We are partnering with several parties to create a network of professionals who are willing to share ideas, best practices, and work toward our overarching Leadership Challenge goal of making “leadership everyone’s business.”

Pfeiffer is committed to helping our customers determine the most appropriate solutions for developing and/or selecting facilitators for their Leadership Challenge programs. With this in mind, we have created a program designed to train and support a community of skilled facilitators. With three levels of participation, the program provides appropriate flexibility for leadership development professionals (both internal and external) in various situations.

- **Level 1 – *The Leadership Challenge® Workshop* Facilitator Training**  
This 4- or 5-day course immerses a facilitator in the basic structure and instructional design of *The Leadership Challenge® Workshop*. It includes participation in a 2- or 3-day *The Leadership Challenge® Workshop* and a 2-day experience that focuses on conducting the Workshop.
- **Level 2 – *The Leadership Challenge® Workshop* Certified Facilitator**  
Certified Facilitators receive additional co-training and coaching experience.

- **Level 3 – *The Leadership Challenge*® Workshop Certified Master Facilitator**

We have formed a special Master Facilitators Network so that we can confidently recommend to customers world-class facilitators, consultants, and coaches. This level takes two years to attain and requires additional co-training, coaching and on-site evaluation. Master Facilitators are the only professionals we will recommend to clients and promote on The Leadership Challenge website ([www.leadershipchallenge.com](http://www.leadershipchallenge.com)).

## **Level 1 – Facilitator Training Workshop**

### **What do I have to do to participate in *The Leadership Challenge*® Workshop Facilitator Training?**

The process is simple:

1. First, you attend a 2- or 3-day session of *The Leadership Challenge*® Workshop as a participant. ## **Level 2 – Certified Facilitator**

### **How do I become a Certified Facilitator of *The Leadership Challenge® Workshop*?**

In order to begin the process of applying for Certified Facilitator status, individuals must complete Facilitator Training steps 1 and 2 above– i.e., attend *The Leadership Challenge® Workshop* and complete *The Leadership Challenge® Workshop* Facilitator Training session. After completing this program, they must secure a recommendation from the Master Facilitator who conducted their Facilitator Training session, secure at least one letter of recommendation from a supervisor, client, or professional colleague, and complete the Certified Facilitator application form. If these criteria are met, the candidate is eligible for consideration and then must complete the following developmental activities:

1. Co-facilitate at least one *The Leadership Challenge® Workshop* with a Master Facilitator, our most experienced and skilled professionals. The Master Facilitator will work along side of you to both conduct portions of the program and also coach you through other parts that you will do solo.
2. Following this co-training experience the Master Facilitator will make a determination about your readiness, and either recommend certification or recommend any additional development you might need.

It is the responsibility of the facilitator-in-training to arrange this co-training experience. Most often these experiences are arranged by the facilitator's organization, or in the case of external consultants, a client organization. We will work with you to locate a Master Facilitator who best fits your needs and with whom you will be comfortable. If you have already attended *The Leadership Challenge® Workshop* and Facilitator Training, as well as facilitated *The Leadership Challenge® Workshop* with one of our Master Facilitators, please contact us. We can discuss next steps with you based on your current situation.

### **What is the cost to me for completing this Certification?**

## Level 3 – Certified Master Facilitator

### What is a Leadership Challenge® Certified Master Facilitator and what is the Master Facilitators Network?

Certified Master Facilitators are highly experienced leadership developers with at least 10 years of experience in the profession of training, facilitation, adult education, and/or line management. They have had at least two years experience conducting *The Leadership Challenge® Workshop*, have received stellar feedback from clients, and have been selected by a group of peers to join the Master Facilitators Network. They are the only individuals who we authorize to conduct *The Leadership Challenge® Workshop* Facilitator Training and to coach and certify new facilitators.

### How can I become a Certified Master Facilitator?

In order to begin the process of applying for Certified Master Facilitator status, individuals must first have achieved Certified Facilitator status (see above). After successfully completing the process, they must secure a recommendation from the Master Facilitator who co-trained their Workshop, secure at least one letter of recommendation from a Workshop participant, and complete the Certified Master Facilitator application form. If these criteria are met, the candidate is eligible for consideration and then must complete the following developmental activities:

1. Co-facilitate one additional *The Leadership Challenge® Workshop* with a Master Facilitator for purposes of observation and feedback.
2. Commit to 10 hours of additional one-on-one coaching with a Master Facilitator. The Master Facilitator and the candidate will jointly determine the use of these 10 hours. Based on experience and prior training, it may be determined that fewer than 10 hours is needed. This determination will be made jointly by the Master Facilitator and the Candidate. Coaching may be in-person or on the telephone.
3. Conduct at least 4 additional *The Leadership Challenge® Workshops* per year for 2 years – a total of 8 additional Workshops. If more than 4 Workshops per year can be scheduled, the time period can be adjusted.
4. Co-facilitate with a Master Facilitator at least one *The Leadership Challenge® Workshop* Facilitator Training program.
5. On post-Workshop evaluations, receive a cumulative average score of 4 on a 5-point scale.
6. Contribute quarterly feedback on personal experiences in facilitating *The Leadership Challenge® Workshop*. A set of common guidelines and criteria will be provided.

7. Contribute at least one Personal Best Leadership case based on in-person interviews to Pfeiffer and Jim Kouzes and Barry Posner. A set of common guidelines and criteria will be provided.

In addition to the development activities described above, Master Facilitators-in-training are expected to participate in the quarterly Master Facilitator teleconferences and attend the annual Master Facilitators Conference. In order to maintain status as a Master Facilitator, individuals must deliver at least four qualifying Leadership Challenge® Workshops over a 12-month period and agree to coach at least two Master Facilitator candidates per year.

### **What is the cost to me for completing the Master Facilitators Program?**

Because of the costs associated with completing the rigorous Master Facilitator program, we recommend that the candidate make sure that s/he will be able to arrange for either corporate sponsorship or has the capacity to independently book the necessary number of Workshops. It has been our experience that successful candidates for Master Facilitator status are either employees of supportive organizations or principals of healthy private training and development firms.
